1. **Ishworpur Municipality** has **allocated funds** towards the cost of **The Procurement of Supply and Delivery of Backhoe Loader** and intends to apply part of the funds to cover eligible payments under the Contract for **The Procurement of Supply and Delivery of Backhoe Loader-NCB/GOODS/01/083/084**. Bidding is open to all eligible Bidders from all countries as defined in ITB Clause 4 (Eligible Bidders)..
2. The **Ishworpur Municipality** invites **electronic** bids from eligible bidders for **The Procurement of Supply and Delivery of Backhoe Loader** under National competitive bidding – Single Stage Single Envelope procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Ishworpur Municipality, Office of the Municipal Executive Ishworpur, Sarlahi** or may visit PPMO egp system www.bolpatra.gov.np/egp.
4. A complete set of Bidding Documents may be purchased from the office **Ishworpur Municipality, Office of the Municipal Executive Ishworpur, Sarlahi** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NPR 0 till **20 August 2026**² during office hours.
Or
Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at **Ishworpur Municipality, Office of the Municipal Executive Ishworpur, Sarlahi** at 11:00AM, **11 August 2026**.
6. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM** on **20 August 2026**. Bids received after this deadline will be rejected.

²The time interval between last purchasing date and last submission date shall not be more than one working day.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **02:00 PM** on **20 August 2026** at the office of **Ishworpur Municipality, Office of the Municipal Executive Ishworpur, Sarlahi**.

8. Bids must be valid for a period of **90 days** from the bid **submission deadline** and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1,16,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a **public holiday³ applicable to purchaser**, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.

³ In case of electronic bid invitation, purchaser shall extend the deadline as required in the e-GP system.
